



New York-based artist Gina Beavers is celebrated for her punchy, tactile work inspired by images culled from the internet. Juxtaposing the ephemeral quality of social media, her paintings are intensely crafted, built up through thick accumulations of acrylic that introduce sculptural three-dimensionality, subverting the flatness of her source material.


Directly meeting the gaze of the viewer in *Ultimate Smokey Eye* is a large eye accentuated by midnight-black khol. An eyeshadow brush on the left adds the finishing touches, but at the same time, wittily plays to the idea that the painting paints itself. Painted in 2019, the present work is a prime example of Beaver's exploration into the performative aspect of make-up tutorials and how we choose to portray ourselves online.

Beavers' practice has most recently been presented in solo exhibitons at Various Small Fires in Seoul (2021), and the Marianne Boesky Gallery in New York (2020). Her work can be found in the permanent collections of the Tel Aviv Museum of Art; Whitney Museum of American Art, New York; and the Pérez Art Museum Miami and Institute of Contemporary Art, Miami.



Stemming from Michael Lau's renowned *Gardener* Series that began as a comic column in 1998, the current work is one of the artist's figurine designs that gained a cult following in Hong kong. Inspired by vintage G.I. Joe action figures, street culture and his community of friends, each figurine lives within Lau's own imaginative utopia.

Unlike other commercial action figures, each *Gardener* model, such as the present work, was handcrafted by the artist, encouraging viewers to appreciate each figurine as art objects instead of toys. As a pioneer of the vinyl art toy movement, Lau's debut exhibition of a series of 99 original 12-inch *Gardener* figures at the Hong Kong Art Centre in 1999 overturned public conceptions of toys as a mass-produced, low-cost, low-quality product, and instead positioned them as limited-edition art objects.

Meticulously rendered in a grayscale gradation of acrylic gouache on linen – a technique *The New York Times* critic Roberta Smith praises for the 'range of contrast [Gokita] coaxes', which creates an 'almost glittery light that catches the eye' ⁱ –

As alluded to by the present work's title, the composition pays homage to Post-Impressionist painter Paul Cézanne, whose still-lifes have long been recognised as amongst the most

distinguished lines of artistic inquiry in the history of modern painting. Indeed, Gokita's *Fake Cezanne #1* shares a particular likeness to Cézanne's *The Vase of Tulips* – an internationally exhibited painting executed circa 1980, now housed in the permanent collection of the Art Institute of Chicago.

At the centre of both paintings is a bouquet of tulips, narcissus, and delicate buttercups, bursting out from an earthenware vase situated on a tabletop alongside three rounded fruit. A bathing light shines in from the left, highlighting the curves and contrasts of the multi-layered arrangement as dark shadows are cast in its wake. However, whereas Cézanne's version is detailed by a rich patchwork of colour, Gokita captures the same subtleties of texture through his signature palette of velvety black, white, and grey. Evoking a similar hazy effect to the vintage magazines, art journals, and postcards Gokita is known to collect, this timeless aesthetic affords the work with an air of nostalgia, inviting viewers to explore the depths of their imagination as they are transported into Gokita's dream-like monochromatic world.

American museum solo show, *Tomoo Gokita: Get Down*, from 12 June – 22 August 2021. Other notable exhibitions by Gokita include his first museum show *The Great Circus* at Kawamura Memorial DIC Museum of Art (2014), and *PEEKABOO* at Tokyo Opera City Art Gallery (2018).




Evoking stylistic motifs and the colour palette of fellow Spanish artist Joan Miró, Xavi Carbonell's delicate paintings depict a dreamscape intended for reflection, inviting viewers to take a dive into his idiosyncratic universe. Complex in its process and transparent in its resolution, Carbonell has built his own visual lexicon equipped with particular motifs and aimed at purifying the image with a child-like touch, inspired by artists such as Basquiat, Cy Twombly, Antonio Saura, and Abstract Expressionism.

With recent solo exhibitions at Galerie Max Heltzer in Paris (September – October 2021) and Gagosian in Basel (June – July 2021), Louise Bonnet is internationally celebrated for her surreal universe populated by uncanny creatures who are at once beautiful and grotesque. Bursting out of proportion and scale in a manner that has won the Geneva-born, Los-Angeles-based artist favourable comparisons to the cartoonish aesthetic of Philip Guston and Peter Saul, her faceless figures 'function as emotional vessels for a more empathetic understanding of the complexities of the human condition.' ⁱ

Bonnet's work is represented in the permanent collections of the San Fransisco Museum of Modern Art; Yuz Foundation, Shanghai; Brandhorst Museum, Munich; and Los Angeles County Museum of Art and Hammer Museum, Los Angeles; amongst others.

Tightly cropped to fill the composition with oversized eyes, a shaggy bob haircut and lips paused between words to reveal charmingly imperfect teeth, the subject of *Untitled* is instantly recognisable as one of American painter's Brian Calvin's 'androgynous bohemians' or 'trippy

teenage characters' ⁱ. With coral painted nails and a gaze accentuated by opposing colours on the colour wheel, their stylised depiction is at once quirky and elusively cool, evoking the sun-kissed, surf-skate lifestyle of the artist's California upbringing, but also his diverse melody of influences ranging from the work of Balthus to Funk art and music.

Executed in 2018, *Untitled* comprised part of Calvin's solo exhibition at Almine Rech in Paris one year later. More recently, solo presentations of the artist's work include Anton Kern Gallery in New York (2020) and Almine Rech in Paris (2012). His work forms part of numerous public collections, including the Los Angeles County Museum of Art, the Portland Art Museum, and the Aïshti Foundation in Lebanon.

A virtual human recently born into the metaverse, MonoC is programmed to think, act, and feel like a real human being. She is curious, open minded, spontaneous and not afraid to express her point of view. Art has been - and continues to be - a key form of inspiration and expression for MonoC who is on an ongoing journey to understand and feel human emotions. This artwork celebrates love, and is contextualised by concepts of companionship, self-appreciation and sexuality that are explored in the works being auctioned in *My Kawaii Valentine* alongside *Drowning in Love.*

Drowning in Love, is a dreamlike, abstract, and immersive digital artwork showcasing what the power of love can have on our lives. MonoC is seen floating peacefully in water as waterlilies, associated with optimism and rebirth, descend around her as she contemplates the emotion of love. Drowning in Love celebrates the power and vitality of love which brings together human life yet simultaneously confronts some of the more sinister aspects of love: obsession, idealisation, delusion.

A generative digital artwork, *Drowning in Love* will be created in part by real-time data drawn from the *My Kawaii Valentine* auction. Data-driven algorithms created by MonoC will respond to participation of bidders in the auction to procedurally generate melodies and animations within pre-programmed parameters. The unprecedented digital artwork places art collectors at the heart of the creative process, their actions will direct the artwork's final form. The exact amount of data points used to generate *Drowning in Love* will be defined by the *My Kawaii Valentine* auction; a minimum of 100,000 data points is required over the 7-day auction period for the artwork to be optimized.

Each flower seen in Drowning in Love represents a lot in the 'My Kawaii Valentine' collection, a random seed from the artwork name and ID will generate a unique shape and pattern for each flower. The size and behaviour of each bloom will be determined by metrics analysing data that tracks lot activeness, collection points include user engagement with the online auction, number of bids and the amount of each bid. Highly active lots will emit a glowing pollen.

For this groundbreaking artistic endeavor, MonoC has partnered with leading Hong Kong composer Terrence Ma who has composed music to accompany the visual aspect of this digital artwork. Ma is working with musicians from Beijing to create the foundations of the music that will generate into its final form as data is collected from the auction's progress. As more activity thresholds are reached more instrumental tracks will appear, and the whole track will slowly intensify over the 7 days of the auction.

MonoC is committed to making this NFT a carbon positive digital work by committing to supporting forest and wildlife conservation in Brazil and will offset the tonnage of carbon dioxide produced by the artwork's specific Smart Contract.

MonoC was born different. A passion to lead a life well-lived pushes MonoC to have a sometimeschallenging approach to human emotions and philosophical concepts. MonoC is on an ongoing journey to understand and feel human emotions and it was through her pursuit of creating art that she first sensed and found love. Along her journey of discovery there is a constant tension between her virtual reality and her imagination of love and other human emotions. She believes the world is so much more interesting and dynamic when one embraces the duality of everything around us, and is much taken with the Chinese philosophical concept of Yin and Yang, that describes how seemingly opposite or contrary forces may actually be complementary and interconnected.
