### SHIPPING & COLLECTION NOTICE



Purchased Lots are available for collection upon Phillips' receipt of full payment of the Purchase Price, plus applicable taxes, and any other amounts due.

#### ART STORAGE

Immediately after the Auction, Lots are transferred to Phillips' shipping and art storage partner, SRI Fine Art Services ("SRI") storage facility in New Jersey. Free storage is provided at SRI for 30 days after the Auction. Buyers who have not collected their Lots within 30 days, will be charged fees of \$10.00 per Lot, per day. Additional fees apply to oversized lots.

#### SHIPPING YOUR WORK THROUGH PHILLIPS

Upon request, Phillips will provide buyers with SRI's shipping quote for purchased Lot(s). Buyers who book their SRI shipment through Phillips will be provided tracking information after Phillips receives payment of all amounts due. To arrange shipping, buyers must send Phillips' Shipping & Collection form to postsalenewyork@phillips.com.

#### **INSURANCE COVERAGE**

Risk of loss or physical damage to a purchased Lot automatically transfers to the buyer on the earlier of full payment and 7 days after the Auction ("Risk Transfer Date"). Thereafter uncollected Lots are at the buyer's risk. It is the buyer's sole responsibility to arrange their own insurance, including transit insurance at the time of shipment. Buyers using SRI to ship their Lots may add optional transit insurance coverage by indicating this on Phillips' Shipping & Collections form.

Phillips is not liable to any buyer for any physical damage or loss to their Lots sustained after the Risk Transfer Date, or as a result of packing, or if it occurs during subsequent transport. Phillips strongly advises Buyers to secure insurance from their preferred insurer.

#### **COLLECTION APPOINTMENTS**

Buyers arranging shipment with their own shipper or collecting in person, must make an appointment by emailing the Shipping & Collections form to Collections@phillips.com. Appointments must be made at least 48 hours in advance of planned collection. All amounts due must be paid prior to arranging a collection appointment.

During the appointment the Lot will be unpacked allowing buyer, or buyer's representative to fully inspect it before collection. A buyer's fine art shipper must also inspect the Lot before repacking it for transport. Shipping agents must bring appropriate packing material when collecting the Lot.

Buyers should arrive prior to the scheduled appointment time and bring identification. The buyer or their representative will not be admitted into the facility without an appointment.

Limited collection is available for selected Lots at Phillips' Long Island warehouse. A Lot will only be transferred from SRI to Long Island if the Buyer provides us with seven day's prior notice via Collections@phillips.com and the planned collection date is within the 30 day post-sale period.

#### PAYING SALES TAX

A Lot's purchase price includes New Jersey sales taxes of 6.63% if the Lot is collected by the buyer in-person or booked by their shipper.

A Lot's purchase price includes New York State and City sales taxes of 8.875% if the Lot is collected by the buyer in-person or if their shipper collects the Lot from Phillips' Long Island City warehouse.

Sales tax rates vary by locality. Buyer's shipping through Phillips to a destination outside New York City are subject to the ultimate destination's sales tax where applicable.

Buyers who are US dealers may be exempt from paying sale tax by providing Phillips with a completed and validated resale certificate.

Taxes and duties applicable to international shipments are payable upon the Buyer's receipt of their Lot and these amounts are not included on shipping estimates.
